CIVIL SERVICE COMMISSION MINUTES THURSDAY, APRIL 6, 2017

CALL TO ORDER: Chairman Cornhoff called the meeting to order at 8:04 AM in Council Chambers.

SWEARING IN:

Law Director, David Maistros gave the oath of office to new member Leonard Taylor. Mr. Taylor was warmly welcomed by the Commission.

APPROVAL OF MINUTES:

Mr. Cornhoff asked if the members had reviewed the minutes from the meeting of March 16, 2017. Mr. Cornhoff asked for a motion to approve the minutes.

The police agility test and exam will be given on May 21, 2017 @ 9:00 am and 1:00 pm respectively. Mr. Taylor advised the Commission that he will be unable to attend the police examination.

Both exams will be given by Ramsey & Associates.

Mr. Taylor asked Asst. Chief Gonsiewski if the Twinsburg police officers wore body cams. After stating that they did, Mr. Taylor commended the Department since they are not mandated until 2020.
