ORDINANCE 75-2022 - AN ORDINANCE AMENDING SECTION 105.01 OF THE CODIFIED ORDINANCES OF THE CITY OF TWINSBURG DESCRIBING AND IDENTIFYING NEW WARDS AND BOUNDARIES IN ACCORDANCE WITH THE REPORT OF THE DISTRICTING COMMISSION AS REQUIRED BY SECTION 3.02 OF THE CHARTER OF THE CITY OF TWINSBURG; AND DECLARING AN EMERGENCY. (Stands on Second Reading)

ORDINANCE 77-2022 - AN ORDINANCE ENACTING NEW CHAPTER 919, “ILLICIT DISCHARGE & ILLEGAL CONNECTION CONTROL” OF THE STREETS, UTILITIES, AND PUBLIC SERVICES CODE OF THE CITY OF TWINSBURG. (Stands on Second Reading)

ORDINANCE 87-2022 - AN ORDINANCE ACCEPTING THE BID OF MUNICIPAL AND CONTRACTORS SEALING PRODUCTS FOR THE 2022 SEWER LINING PROJECT; AND DECLARING AN EMERGENCY.

ORDINANCE 88-2022 - AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH AT&T FOR THE PURPOSE OF REPLACING THE DISPATCH CENTER'S PHONE SYSTEM AND ASSOCIATED PROFESSIONAL SERVICES THEREFOR; AND DECLARING AN EMERGENCY.
